Fast-Track Scheme

For Solicitors/Barristers where Court dates are involved please give us 10 working days' notice for Medical Reports or copies of Medical Records.

For urgent matters where a 72 hour turnaround timescale is required or a fax-back (Safe Haven only) a £21.50 'fast-track' in the fee is payable.

Courier or Recorded Delivery of items will be at additional cost. Please discuss requests for same day service.

Additional costs may be incurred (e.g. overtime or holiday pay) and we cannot always commit to being able to complete requests on a same day basis. We will always try to assist wherever possible but clinical priorities may prevent us from meeting requests for same day service for medical reports.

Access to Medical Records

In accordance with the General Data Protection Regulation 2018, Data Protection Act 2018 and Access to Records Act 1990, patients may request to see or have a copy of their medical records. Such requests should be made through the practice manager. No information will be released without patient consent unless we are legally obliged to do so.
